

## NOTICE OF MEETING


### BRAZORIA COUNTY MUNICIPAL UTILITY DISTRICT NO. 26

The Board of Directors of Brazoria County Municipal Utility District No. 26 will hold a regular meeting on **Tuesday, May 7, 2019, at 11:00 a.m.**, at the office of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Colorado Room, Houston, Texas, to discuss and, if appropriate, act upon the following:

1. Convene in Executive Session pursuant to Section 551.076, Texas Government Code, to deliberate the deployment, or specific occasions for implementation of security personnel or devices, or a security audit and to discuss security report and any new security patrol agreements.
2. Reconvene in Open Session and authorize appropriate action regarding deployment, or specific occasions for implementation of security personnel or devices and approve any necessary actions related to security report.
3. Minutes of prior meeting(s).
4. Newsletter and website, including approve articles and postings.
5. Comments from the public.
6. Development in the District and approval of any financing agreements, execution of waivers of special appraisal, and approve any developer reimbursement reports and disbursement of funds.
7. Financial and bookkeeping matters, including:
  - a. payment of the bills and investment of District funds.
8. Authorize Director Expenses for the Association of Water Board Directors summer conference and discuss Travel Reimbursement Guidelines.
9. Tax assessment and collection matters, including delinquent tax collections, installation agreements, and payment of tax bills.
10. Engineering matters, including:
  - a. design of District facilities, approval of plans and specifications, authorization to advertise for bids, award of construction contracts, and execution of any related letter financing agreements;
  - b. construction of District facilities, including approve pay estimates, change orders, and final acceptance, as appropriate;
  - c. deeds and easements; and
  - d. update on City of Pearland's expansion of sewage treatment plant.
11. Storm Water Permit TXRQ40000.
12. Reports from Directors, District consultants and SCRMA regarding events and activities attended during the month, and presentation and attendance at City Council, or City related meetings or events or AWBD

or other conferences, and discuss assisting SCRMA with payment for certain items eligible for MUD expenditures, including erosion protection and irrigation improvements for detention pond slopes.

13. Attorney's report.
14. Blue Ridge Landfill Odor matters and efforts to ensure compliance of the Landfill's Texas Commission on Environmental Quality permit.
15. Convene in Executive Session, if necessary, pursuant to Section 551.071, Texas Government Code, to conduct a private consultation with attorney to discuss pending or contemplated litigation related to Blue Ridge Landfill, including Texas Commission on Environmental Quality monitoring regarding permit violations.
16. Reconvene in Open Session and authorize appropriate action regarding pending or contemplated litigation related to Blue Ridge Landfill, including Texas Commission on Environmental Quality monitoring regarding permit violations.
