BRAZORIA COUNTY MUNICIPAL UTILITY DISTRICT NO. 26


The Board of Directors of Brazoria County Municipal Utility District No. 26 will hold a regular meeting on **Tuesday, September 3, 2019, at 11:00 a.m.**, at the office of Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, Colorado Room, Houston, Texas, to discuss and, if appropriate, act upon the following:

1. Convene in Executive Session pursuant to Section 551.076, Texas Government Code, to deliberate the deployment, or specific occasions for implementation of security personnel or devices, or a security audit and to discuss security report and any new security patrol agreements.
2. Reconvene in Open Session and authorize appropriate action regarding deployment, or specific occasions for implementation of security personnel or devices and approve any necessary actions related to security report.
3. Authorize auditor to conduct audit for fiscal year end September 30, 2020.
4. Resolution Commending Fred E. Weary Jr. for Service to Brazoria County Municipal Utility District No. 26.
5. Minutes of prior meeting(s).
6. Newsletter and website, including approve articles and postings.
7. Comments from the public.
8. Development in the District and approval of any financing agreements, execution of waivers of special appraisal, and approve any developer reimbursement reports and disbursement of funds.
9. Review Arbitrage Rebate Reports for the Series 2009 and 2014 Bonds.
10. Financial and bookkeeping matters, including:
 - a. payment of the bills and investment of District funds;
 - b. adopt budget for fiscal year end September 30, 2020;
 - c. conduct annual review of Investment Policy and adopt Resolution Regarding Annual Review of Investment Policy; and
 - d. review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions.
11. Tax assessment and collection matters, including:
 - a. delinquent tax collections, installation agreements, and payment of tax bills; and
 - b. conduct public hearing regarding District's tax rate, adopt Order Levying Taxes, and authorize execution of Amendment to Information Form.

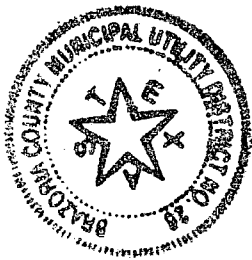
